Item 9. Other events

Philippine Business Bank (PSE:PBB) will be releasing its earnings release today, August 6, 2024. Below are the key highlights of the earnings release.

Income showed high-teens growth YoY :

- Interest income reached ₱5,184.1 million in the first half of 2024, a 17.2% increase year-over-year ("YoY")
- Core income¹ at ₱1,710.0 million in 1H24, up 21.4% YoY
- Profit before tax rose to ₱1,382.2 million in the first six months of 2024 from ₱1,163.5 million in the same period last year, an 18.8% growth
- Net income ended at ₱1,032.0 million in June 2024 against ₱869.2 million in 1H23, surging by 18.7%

Sustained balance sheet growth (1H 2024 vs 1H 2023):

- Total resources stood at ₱154.4 billion in 1H24 a 12.6% increase YoY

¹ Core income is total revenues ex-trading gains/(losses) less non-interest expenses

- Loans and other receivables at ₱118.7 billion, up 14.3%
- Total deposits reached ₱126.4 billion in 1H24 a 12.5% growth YoY
- Total equity grew ₱1.3 billion to ₱18.4 billion
